RULES & REGULATIONS

This document informs you of the various rules and regulations of Jharkhand Super-40. Please read this carefully and sign at the end for acceptance.

- (a) Fee once paid will not be refunded or adjusted at any stage, under any circumstances.
(b) In case of a student who gets enrolled for the long term classroom program, under extra ordinary circumstances, certain part of the fee (strictly after deduction of admission fee, registration fee and taxes) may be considered for refund on sole discretion of top management of the institute and specific company policy of the refund (Policy available with the accounts department).
- Students enrolled at Jharkhand Super-40 Classroom centre have to maintain proper decorum in the institute premises at all time. Indiscipline of any form or misbehaviour with staff could lead to suspension/termination.
- Delay in payment of fee will attract a late fine of Rs. 50/- per day, including holidays.
- Students who frequently come late to the institute or absent themselves without information may not be allowed in the institute premises without permission.
- Student absent from the class for more than 10 days in a row is required to intimate the institute's management. In case of absenteeism for long period without prior intimation, the admission of the student may be deemed cancelled without notice and without any refund of the fee.
- Any change in address or mobile number of student/parents should be notified to the office without delay.
- Student must be in possession of Identity Card while coming for classes and must produce the same for scrutiny to the Jharkhand Super-40 staff before entry, if asked.
- If any cheque is dishonored for any reason, appropriate action may be initiated as per Negotiable Instrument Act. An administrative charge of Rs. 250/- will be levied for every dishonored cheque and the fee in lieu of the dishonored cheque will only have to be submitted via a Bank Demand Draft/Pay Order/Cash.
- In case of any increase in the GST or Education Cess by the Government of India, such increase in tax shall be borne by the student/parent from the date of notification by the Government of India.
- The student is responsible to see for himself/herself whether he/she is eligible for a certain examination/course or not. The institute will not be held responsible if the student's admission form is not forwarded or is rejected on any ground. Getting admission forms and submitting to the examination body IIT-JEE/NEET or other Engineering/Medical entrances will be sole responsibility of student/parents.
- Jharkhand Super-40 reserves the right to use student's photograph and testimonial letter in any promotional and publicity material of the institute.
- In order to help the student, the institute may provide information about some private hostels being run in the vicinity of the institute, if he/she is not willing to avail Institute's hostel facility. Jharkhand Super-40 does not take any responsibility of any hostel whose information may be provided by it.
- Jharkhand Super-40 reserves the right to change or alter the classroom programs, fee or rules and regulations without any prior notice to anybody. The management decision shall be final and binding on the student and parent.
- We adopt zero tolerance policy against any indiscipline, abusive language, misbehavior with teacher/staff of the institute, fighting with each other, eve-teasing or any other disturbance, unlawful activities by the student within or outside the institute at any given point of time till the student is enrolled with the institute. Management may terminate such student found indulged in any of the above maintained activity by giving termination notice. No fee refund is permissible in such cases.
